

Sky Family Fund eligibility

Eligibility to the Sky Family Fund Emergency Fund is limited to cases of serious injury* or death.

Serious injury:

- An injury which causes loss of or significant limitation of use of a body organ or system
- An injury which impedes normal life for at least 90 days out of the 180 days following the accident.

* Please see detailed definition below.

Eligibility is limited to accidents that occur in the present or accidents that took place within the past year and which still significantly impede normal functioning.

All those reaching out to Care-All and who fit the above criteria will be eligible for the immediate relief fund.

All those in the skydiving and base-jumping communities who need support following any accident regardless of when it took place or the nature of it, are eligible to set up a page within Sky Family Fund.

Funds distribution:

Level 1 payout:

The amount available for the eligible persons will be directly proportionate to the amount of funds available.

< €100 000 in the fund:	1/20th of total per person
€100 000-€500 000	Max €5000 per person
€500 000-€1M	Max €10K per person

Maximum initial payout: 5000 euro

Should there be more than one affected person in a single incident. The amount allotted to the first person, will be summed to that allotted to the second and so forth. The total will then be divided by the number of people affected so that each case in the same incident receives the same amount.

Level 2 payout:

Eligibility for a second payment:

1. Out of pocket medical expenses in excess of 20'000 euro.
2. Personal hardship caused by inability to work for more than 6 months and having dependents or lack of unemployment benefits.
3. Request for contribution for essential long term rehabilitation expenses not covered by insurance.

By qualifying in one or more of these additional brackets, the recipient may be eligible (at the discretion of the fund managers) for a second payout of up to 5000 Euro.

** Level 2 payouts will only come into effect when there are available funds after level 1 payouts.

**Serious injury is defined as "a personal injury which results in death; dismemberment; significant disfigurement; a fracture; loss of a fetus; permanent loss of use of a body organ, member, function or system; permanent consequential limitation of use of a body organ or member; significant limitation of use of a body function or system; or a medically determined injury or impairment of a non-permanent nature which prevents the injured person from performing substantially all of the material acts which constitute such person's usual and customary daily activities for not less than ninety days during the one hundred eighty days immediately following the occurrence of the injury or impairment." *** Payments for the Sky Family Fund Emergency Fund will be send to the beneficiaries on a necessity basis.
Payments for the Sky Family Fund pages will be sent to the beneficiaries at the end of each trimester.*
